SPECIAL PATENT

a public instrument issued by the government to confirm ownership over a parcel of agricultural land (alienable and disposable) by law or proclamation by the President of the Philippines

DENR, through the Land Management Bureau (LMB), issued DENR Administrative Order (DAO) No. 2016-21 Guidelines Governing the Processing of Requests for Proclamations and Issuance of Special Patents Over Agricultural Lands



THINGS you should know



PROCESSING TIME

From several years of processing, it is now limited to $\underline{120 \text{ DAYS}}$



SCOPE AND COVERAGE

01 All public agricultural (alienable and disposable) lands granted by the State in favor of a government instrumentality by law or by Presidential proclamation




Lands occupied and used by government institutions for public use or public purpose



The special patent is issued in the name of the Republic of the Philippines and its agencies, branches or other instrumentalities such as government -owned and -controlled corporations, and local government units such as provinces, cities and municipalities.

BASES OF DAO 2016-21



Provides that public land actually occupied and used for public schools, municipal halls, public plazas or parks and other government institutions for public use or purpose may be issued special patents

Mandates CENRO to process the special patent request within 120 days and the PENRO to approve it within 5 days

Authorizes the DENR to disseminate rules and regulations to carry out provisions of the law

PUBLIC PURPOSE


Properties for public purpose are lands used exclusively by the government or any of of its instrumentalities in providing services to the general public including: marketplace, town, city, provincial or barangay halls, hospitals and health centers, police stations, outposts, and jails.



PUBLIC USE

Properties for public use are those which are open to the general public, such as: public plazas, resorts, roadways, recreational facilities, libraries, meeting places, playgrounds, and public parking lots.









Certification stating that there is no pending land registration case



The issuance of Special Patents for the titling of government lands are expected to provide the following benefits to LGUs, NGAs and other government institutions.



Secures tenure over public property thereby reducing possibility for land grabbing, illegal settlement/ possession and deceitful occupation



Provides new economic opportunities especially for LGUs

Defines the property for proper accounting and enforcement of rights





Quiets doubts on the ownership of the property saving the government time, money and effort in taking care of public property

SCHOOL SITE TITLING MADE EASY

DENR AO 2015-01, "Guidelines for the Processing and Issuance of Special Patents for Public School Sites Under Republic Act No. 10023", provides for an easy, fast and affordable process of having Special Patents issued on untitled lands actually possessed and occupied by public schools.

Many public school sites do not have title to their lands making them vulnerable to illegal occupation, intrusion, and adverse claims of ownership. Republic Act No. 10023 and the DENR Administrative Order No. 2015-01 gives way for public schools to apply for titles.







CHECKLIST

WHAT TO BRING TO CENRO WHEN YOU REQUEST FOR A SPECIAL PATENT ON SCHOOL SITES?

Accomplished Request Form for Issuance of School Site Special Patent (Annex of DAO 2015-01, available at the CENRO and online)

Historical background of possession (narrative on how the school came into possession of the land being applied for including relevant dates). This should contain the information on how the total land area was acquired by the school.

Recent photographs showing the panoramic view of the area as well as adjacent areas, vicinity improvements introduced, buildings, landmarks, identifying features, settlements, fences, etc.

Court/Land Registration Authority certification that there is no pending land registration case on the land or any portion thereof; and

Copy of approved survey and technical description

REMEMBER!

All lands of public schools state universities and colleges are covered as long as they are:

Devoted to and incidentally used for education and education related services such as offices, canteens, gardens, athletic fields, sports complex, sports courts, clinics, gymnasiums, car parks, science centers, nature parks and other related areas.

Actually possessed, occupied or used as school site regardless of period of possession

Classified as agricultural land (alienable and disposable)
